All Brackett ISD campuses will operate the Community Eligibility Program (CEP) under the National School Lunch Program and School Breakfast Program for the 2025-2026 school year. All BISD schools operate CEP and serve **breakfast and lunch** to all children at **no charge**.

We also provide Breakfast in the Classroom for the elementary students daily. The cafeteria is happy provide more than 600 meals per day to students and staff throughout the district, and employ 7 team members.

Following the nutrition guidelines prescribed by the Healthy, Hunger-Free Kids Act of 2010, we serve whole-grain rich products; low fat and fat free milk; 100% fruit juices; and a variety of fresh, seasonal fruits and vegetables.

If you are the parent of a student in grades PK through 12, you **will not** complete the comprehensive free lunch application. Instead, you will fill out a simple, one-page socioeconomic form, which has important benefits to the district and your child.

If you are needing this form for applications or testing discounts, please reach out to your child's campus for help retrieving the form.
